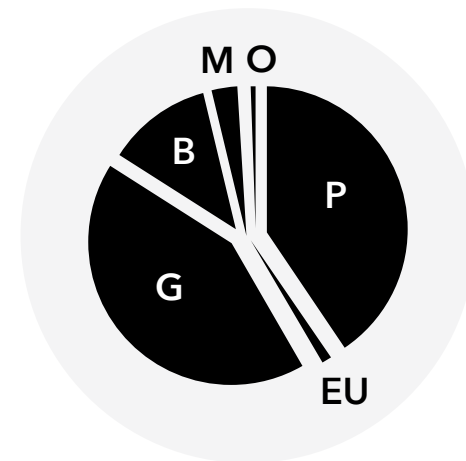
NOVEMBER

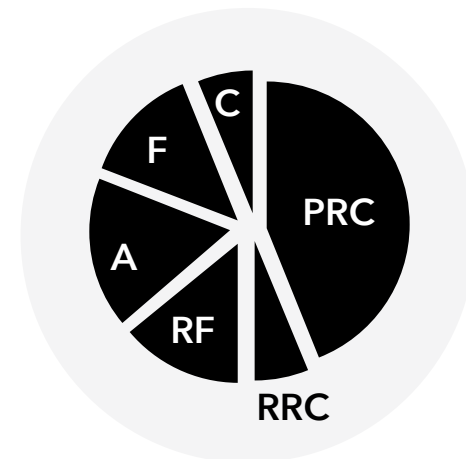
